Abstract: After reviewing the literature on fiscal space, the thesis tries to compare between the **conventional** ways and the **efficiency**-enhancing ways of fiscal space creation especially on the revenue-mobilization and public expenditure sides. The study uses **Egypt** as a case study. First, it analyzes the domestic **feasible** ways of creating fiscal space in Egypt by using the Egyptian **tax effort** index and by running **Data Envelopment Analysis (DEA)** to examine the efficiency of public spending. Second, the study uses a static **Computable General Equilibrium (CGE)** model to assess the macroeconomic impact of the different feasible ways from both a conventional and efficiency-enhancing perspectives. The results show that there is a room for creating fiscal space in Egypt using tax revenues and expenditure reform. The macroeconomic impact of all simulated tax and expenditure scenarios is contractionary in the short run; however the efficiency-enhancing ways may be economically preferable in both the short and long run.
